In The News

• A recent article in *Progressive Dairyman* discussed navigating the legal implications of direct milk supply contracts. While dairies continue to struggle with difficult decisions, some farms have begun to turn to private contracts to ensure their market and avoid pricing volatility. Admittedly, the idea may be more suited to larger farms, but not necessarily so. Regardless, there are many potential pitfalls in the contracts, and the advantage is usually not with the producer. Nevertheless, there is at least one law firm working to level the playing field and help supply contractors fix the shortcomings in the contracts, so that if this trend really catches hold in our industry, the contracts should be more equitable.
