Topic of the Month

Getting Ready for the Fair

Somerset County's fair will take place later this month. Now is the time to make sure your animals will meet the health requirements. In order to be effective, the final dose of a vaccine should be given at least two weeks before the animals leave the farm.

Cattle are required to be vaccinated against shipping fever and rabies. Swine are required to receive two doses of an Erysipelas vaccine. Breeding sheep are also required to be vaccinated for rabies.

The rabies vaccine has been controversial in years past. Studies have tried to demonstrate its efficacy by measuring titers, or levels of protective antibodies, in vaccinated animals. Not all animals will respond to this vaccine, particularly animals that are vaccinated young, but it does appear that older animals and animals that have been vaccinated in consecutive years will tend to have a titer. We assume this is protective, as the antibodies seem to provide good levels of protection in other animals such as dogs and people.

Finally, all animals must have official identification in the form of an official USDA metal, scrapie, or 840 tag.

Please call the office to schedule inspection for health certificates. When calling, please have the ID, age, sex, breed, and vaccination information for your animals. To save time, we will have the health charts filled out before inspection so that on farm, we can verify ID, inspect, and sign.

• The supervisors of Todd Township, Huntingdon county, PA, have passed a law banning "industrial farming", which is defined as farms where the animals are not owned locally, most of the revenue does not stay in the township, or the farms are contrary to the scenic values that provide the township's rural character. According to an online article in Farm Journal's Milk, similar laws have been passed and struck down before because they overstep the township's authority and are in violation of state law. The legality of the statute has already been challenged with the state Attorney General's office.
